The sessions as well as the test, covers predominantly the -14 chapters, in the Payroll Source.



Update: June 2014

Tax Intelligence: Forecasting SUI Tax Rates

Situation

From 2013 to 2014, average unemployment tax costs dropped \$40 per employee, from \$530 to \$490. That decrease represents a continued rebound from the 2012 high of \$567 per employee and offered welcomed relief to employers. At a macro level, these decreases are largely derived from reductions in unemployment claims volume and the unemployment or jobless rate (6.3% in May 2014), as lower unemployment benefit charges lead to lower state unemployment insurance ("SUI") tax rates. However, each employer may face radically different rate assignments from year-to-year based on factors unique to each employer. By recognizing these factors and their nuances, employers are better able to predict or forecast SUI tax rates, which may differ Impact of Employer-Specific Factors on SUI Tax Rates

dramatically from national averages.

Solution

Rate Calculation: Reserve vs Benefit Ratio

The two main methods of calculating a SUI tax rate are the Reserve Ratio and Benefit Ratio methods (for additional information, please see the September 2013 issue of Tax Intelligence). Key factors impacting both methods include benefit charges and taxable payroll. In both methods of calculating a SUI tax rate, as benefit charges decrease tax rates decrease. However, the same does not hold true for taxable payroll. In Benefit Ratio states, increases in taxable payroll lead to SUI tax rate decreases, all else

remaining constant. In Reserve Ratio states, increases in taxable payroll lead to tax rate increases. It is also important to note that in Benefit Ratio states, the rating calculation only goes back three to five years. If an employer experiences a high benefit charge year, after three to five years, the negative impact of the charges "drops off" from the rating calculation. However, since Reserve Ratio states use a cumulative reserve account balance, a high benefit charge year becomes embedded into the employer's experience indefinitely.

M&A Impact on Tax Rates

During the last four completed calendar quarters, there was a 20% increase in M&A transactions. M&A transaction can alter SUI tax rates depending on how the transaction is structured and the unemployment experience of the employers involved. Once a transaction takes place, employers must file compliance documents timely or risk "SUTA Dumping" allegations by state workforce agencies (for more information, see the May 2014 issue of Tax Intelligence). As part of the compliance reporting process, employers must consider the impact to rates when/if experience is transferred between employers, including when such transfers will become effective. If a transaction involves large transfers of workforce, future rates may also be impacted by the taxable payroll being transferred. Beyond rate impacts, employers should review any opportunities for wage base carryovers (FICA, FUTA, and SUI) when transactions occur mid-year.

Rate Add-Ons

Budgeting for state unemployment tax costs should also incorporate rate add-ons and assessments that states use to cover such costs as training, health care, administration, and interest associated with borrowings from the federal government (for additional information, please see the September 2013 issue of Tax Intelligence).

Value

Unemployment tax rate forecasting offers employers the ability to determine how the past year's employer-specific factors, including taxable payroll fluctuations, benefits charged, and M&A transactions, might impact your organization's SUI tax rates. By doing so, unexpected tax costs can be avoided, whether higher or lower than anticipated.
